He emphasized that the survey work completed by Morell Engineering and respective map supplied by Morell did not establish boundaries but instead located and marked existing limits. Attorney Black discussed the potential need for a resolution to state that The Town of Mooreville Limits Map by Morell Engineering is a correct depiction of the corporate limits of the Town of Mooreville.
